#### John Doe v. Jane Doe

Jane was a college student who reported sexual misconduct by a fellow student to her school. The college conducted a formal Title IX investigation process and hearing, and ultimately found the Respondent responsible for sexual misconduct in violation of its Title IX policy, and removed him from the college. The Respondent brought a defamation suit against Jane, which is still pending in court. Case Adopted January 2023

#### Louk v. Visible College

Mara Louk was a senior at Visible Music College, a private Christian school, when a fellow Visible student forcibly raped and strangled her. Visible refused to investigate Mara's report of the assault, and instead disciplined Mara for allegedly having premarital sex with a prior boyfriend. Mara filed a complaint with the U.S. Department of Education, and the Department is now investigating Visible for retaliation and other violations of the Clery Act and Title IX.

### Advocating For Equity

Every year, AAUW California tracks legislation that will



advance equity and fairness for women and girls. Volunteers throughout the state meet with their legislators to request their support for bills that advance this cause.

This advocacy is central to our mission as the American Association of University Women.

This year, the bills selected by AAUW-CA for support include:

Assembly Bill 1394: This bill would enable survivors of child sexual abuse to sue to get their images removed from social media and collect penalties from platforms that refuse to delete their images.

AB 1394 would also permit victims to sue those who trafficked them. Since 2000, traffickers have recruited 55% of their victims online, often through social media platforms.

Assembly Bill 287 would also enable parents and child victims to sue social media that knowingly or negligently expose children to content that promotes addiction or inflicts other harm, such as inducing eating disorders.

According to supporting material, 38% of tweens and 84% of teens use social media, and platforms such as Instagram and TikTok have worsened body image, promoted eating disorders and prompted selfharm among teen girls.

Assembly Bill 549 is the California Elimination of Discrimination Against Women Act. It would require all state agencies to conduct self-evaluations of possible discrimination in the implementation of their policies and programs. Similar language has been ratified by 187 nations.

AB 549 is seen as increasingly important because of the economic setbacks suffered disproportionately by women during the Covid-19 pandemic.

AAUW-Redlands is seeking volunteers to meet in teams of three or more with our state legislators to advocate on behalf of these bills. We need to do this before the legislative session goes into recess for the summer.

### Sharing is Caring

Members of the Victor Valley Branch of AAUW have a long tradition of hosting a STEM Conference for 8<sup>th</sup> Grade Girls that they called their "Celebrating Women in Math and Science Conference (CWIMS)." Up until the pandemic, the conference was held at Victor Valley College where workshops were provided by women who are STEM professionals. The conference was structured almost exactly like our STEM Conferences for Redlands-Yucaipa girls and for Banning-Beaumont girls.

Since the pandemic, the Victor Valley Branch of AAUW has been unsuccessful at recruiting new members and the membership has made the very painful decision to close the branch. Since the branch was organized in 1955, we are sympathetic to the emotions surrounding this decision.

Victor Valley Branch decided recently to share their remaining CWIMS funds"(\$5,985) with us because our STEM Conferences meets the same goals as the Victor Valley CWIMS Conference. This is a very generous donation to our branches' shared desire to help young women gain interest and confidence in STEM courses and careers.



Victor Valley also transferred their successful fundraising project—selling TechTrek bears to participating branches—to our branch, along with their inventory of 100 bears.

We are grateful for this gift and will remember the Victor Valley Branch with fondness and respect.

#### **AAUW CA Promotes its Priorities with the Legislature, Prepares for a Vote on New Ones** By Ginny Hatfield, Amy Hom and Kathi Harper, AAUW CA Public Policy Committee

If you participated in this year's Lobby Days on March 21st and 22<sup>nd</sup>, you know it was a whirlwind of activity. Over two jam-packed days, 120 AAUW CA members from 50 branches met with 46 Assembly offices and 23 Senate offices. Most of the meetings took place via Zoom and the majority took place without a hitch. For the first time, some of our members met in person in Sacramento.

While most meetings were conducted with legislative staff we were able this year to schedule 10 meetings with the members themselves - 6 Assemblymembers and 4 Senators. In addition, Kathi Harper, AAUW CA Public Policy Chair, and Kathy Van Osten, our AAUW CA Legislative Advocate, met with the Governor's staff and Assembly Speaker Anthony Rendon's office.

We were happy to learn that our organization was known to many of the legislative staff and legislators with whom our members met. Some had spoken to branches in their districts; others were familiar with our public policy priorities and expressed alignment and support for them; and a handful were appreciative of the background we provided about our mission and programs. A sterling endorsement came from none other than Alf Brandt, Policy Consultant for Assembly Speaker Anthony Rendon, whose mother was an AAUW member in the 1940's in Orange County. He credits her involvement in AAUW "making me the man I am today." The reception of our "Top 3" bills - AB 1394, SB 287 and AB 549 – was generally favorable, especially the two social media bills. Both staff and legislators could identify with the pervasive problem of having children who are or will be targeted by social media. AB 549 needed a bit more explaining, as some were unfamiliar with CEDAW, the Convention on the Elimination of all Forms of Discrimination Against Women. During our Lobby Days event, we were able to get our message across to those who make our laws and to highlight AAUW, our mission, accomplishments and the benefits we bring to our communities throughout CA. It was an empowering exercise in advocacy and for those of you who participated, AAUW CA thanks you! **Adding this reminder:** it's time to vote on the updates to the Public Policy Priorities for 2023-25. In response to input from 466 members, the state Public Policy Committee has recommended and the Board has approved 11 changes, which can be viewed here: <u>https://www.aauw-ca.org/2023-proposed-public-policy-priorities/</u>. Highlighted additions include support for: civics education, access to diverse staff and curriculum, safe infrastructure and access to technology in our schools, gun violence prevention, and a fourth pillar to support women in leadership roles. Voting opens April 22<sup>nd</sup>, make sure you make your voice heard!
